B. Monthly/YTD revenue and expenses

Jenn Nguyen reported on the monthly revenue and expenses for July 2024. Fund 870's starting balance was approximately \$8.82M. There was no revenue. Expenditures were \$1.5M which was a transfer to fund 871. The ending balance was \$7.32M. Fund 871 had a starting balance of \$10.94M. The fund received \$1.5M revenue from the 870 transfer and expenditures totaled \$97.6k. The ending balance for fund 871 was approximately \$12.35M. Including \$25M in the state advance fund, the Agency's combined cash position for the month was approximately \$44.67M. As of 9/10/24, the Agency's combined cash position was approximately \$44.53M.

Finance is currently closing out the books for FY23-24. The completion is anticipated sometime in October.
